# PUBLIC DEBATE:

## **A KEY PHASE OF THE PROJECT**

In June 2012, Éolien Maritime France referred to the National Commission for Public Debate (NCPD)\*, an independent administrative authority in charge of ensuring the respect of public participation in the procedures of infrastructure planning and development projects.

In view of national interests, environmental impact, related infrastructure and the socio-economic challenges of the wind farm project off the coast of Courseulles-sur-Mer, the NCPD has decided to **organise a public debate and has set up an SCPD to oversee the process.** 

The wind farm will involve the construction of 75 offshore wind turbines each with a capacity of 6 MW, generating a total energy output of 450 MW. It will be constructed between 6 and 10 miles from the Calvados coast, near Courseulles-sur-Mer.

## WHO DOES WHAT?

**The Special Commission for Public Debate** (SCPD) will oversee the debates and organise discussions. It will not rule on the merits of the project. Its task is to provide complete, transparent and objective information to the public and to give the public the opportunity to be heard (public meetings, website, contributions, committee room, etc.). The commission will also ensure that the contracting authority answers all questions raised by the public.

The contracting authority, Éoliennes Offshore du Calvados\*, will present the project to the public and answer all questions.

The SCPD and the contracting authority may also rely on experts to explain particular aspects.

\* Eolien Maritime France has incorporated a company to handle the execution of the Courseulles-sur-Mer offshore wind farm, it is called Éoliennes Offshore du Calvados.

## WHO CAN GET INVOLVED?

The public debate process is open to all. The location of the project off the D-day landing beaches fully justifies the participation of any British, Canadian and American nationals who may have concerns.

All individuals and organisations have the right to ask questions and give their opinions with equal rights to speak.

The documents produced by the SCPD and the contracting authority are available to everyone on the website **www.debatpublic-eolien-en-mer-courseulles.org**.

Public meetings will also be announced in the press and through a poster campaign.

## PROJECT SCHEDULE AND DEBATE TIMEFRAME



\*From April 2012 to mid-October 2013. This phase identifies the risks that the project is not executed or that commissioning is delayed.

# WHAT WILL THE DEBATES BE ABOUT?

Issues and topics under debate:

- Energy challenges
- Impact on the countryside and natural areas
- Benefits for the local economy
- Impact on shipping, fishing and tourism
- Impact on historic sites and memorials
- Connection to the national grid
- Port facilities

> All these issues will be covered and debated over the course of the 11 planned public meetings.

# THE PROJECT IN FIGURES

The wind farm will be constructed at least **6 miles** off the coast of Courseulles-sur-Mer

Its total area will be 12 acres

75 wind turbines with a height of 570 feet (mast + blades), separated from each other by a distance of around 1/2 mile

They will be connected to the national grid by under-sea and underground cables

The total cost will be **1.8** billion Euros



# PUBLIC DEBATE: THE GOALS

The debates will take place between 20 March and 20 July 2013.

The public debate process has four main goals:

- To inform the public about the construction of the wind farm off the coast of Courseulles-sur-Mer: opportunities, challenges, main characteristics;
- To allow all interested parties to express their opinions, to comment, to ask questions, and to make suggestions and proposals concerning all aspects of the project;
- To give everybody the chance to understand the positions and arguments of all parties concerned;
- To inform the contracting authority of any new assessment factors.

## PUBLIC DEBATE: THE PRINCIPLES

The NCPD and the SCPD must comply with the following principles:

**Neutrality:** The SCPD will not take sides concerning the topic being debated. They will oversee the quality of the public debate. **Independence:** The SCPD is entirely independent of the contracting authority and all other parties involved in the debate.

**Transparency:** All information relating to the project and the debating process is made public. The SCPD is an open and accessible commission.

Equity: Any person who has concerns about the project may be heard, whatever their status.

All citizens, institutional representatives, associations and experts will have an equal right to speak.

**Confrontation and respect for arguments:** The SCPD will make sure that all opinions expressed are well founded and that everyone enjoys their right to be heard.

## PUBLIC DEBATE: WHAT HAPPENS NEXT?

Within a period of two months from the close of the debate, the President of the SCPD will publish a report on the public debate and the President of the SCPD will give a summary overview.

Within three months of the publication of these documents, the contracting authority will make an informed decision and make known the actions they intend to carry out, taking into consideration the information provided during the public debate. If they decide to proceed, they will announce how they intend to provide information to the public and how the public can participate during the course of the project. They will also specify the measures they intend to implement in response to the issues raised during the debate.

## HOW TO GET the information you need and participate in the debate ?

The SCPD provides you with a variety of tools. You can acquire essential information and participate in the public debate during the four months it lasts.

- Participate in the 11 public meetings organised in Calvados.
- Download documents on the debate (records of the contracting authorities, studies, RTE (company responsible for high and very high voltage electricity transportation in France) contribution and minutes of the public meetings). You can ask questions on the debate website and give your opinion about the project. The contractor's documents are available in English on the SCPD website.

Your document requests, questions and opinions can also be sent to the SCPD using the T coupon, by post or by email.

- **Provide a written contribution** with details of your arguments concerning the project. Some of these contributions will be kept by the SCPD to be included in stakeholder reports. They will then be formatted to standard and printed by the SCPD before being handed out at meetings. They will also be available on the Internet and through subscription.

- You can also view the available documents and studies concerning the debate at the offices of the SCPD in Bayeux\* and every Tuesday morning at the information desk in the Town Hall of Courseulles-sur-Mer.
